About your pack of Cimizt®

Each pack of Cimizt® contains 63 tablets presented in 3 x 21 blister pack strips, which is sufficient for 3 separate 28 day cycles of contraceptive cover.

Each box of Cimizt® also contains a detailed **Patient Information Leaflet**, which you should read carefully and put in a safe place. This provides important information that you should know when taking Cimizt®, such as guidance on:

- What to do if you miss a pill or several pills
- What to do if you are late taking your pill
- Medicines or illnesses that could make your pill less effective
- Potential side effects, and what to do if they occur
- Warning signs that indicate you should stop taking Cimizt® and consult your doctor

About your Cimizt® prescription

Your doctor or other healthcare provider has prescribed Cimizt® as your oral contraceptive method.

Cimizt® is a combined oral contraceptive or 'birth control' pill that is taken to prevent pregnancy.¹ Each tablet contains 150 micrograms of desogestrel and 30 micrograms of ethinylestradiol.¹

One tablet of Cimizt® should be taken every day until the blister strip is completed, followed by a 7 day pill-free interval before starting the next blister strip of Cimizt® tablets.¹

If you received Marvelon® previously

Cimizt® contains the same active ingredients in the same amounts as Marvelon®, and is therefore considered to work in the same way.¹⁻⁴

Changing to Cimizt® is as simple as getting used to the new packaging – you'll take the same number of tablets each month, and request repeat prescriptions in the same way as when you took Marvelon®.^{1,2} When taken correctly, Cimizt® is just as effective at preventing pregnancy as Marvelon®.^{3,4}

Things to remember when taking Cimizt®

Please read the Patient Information Leaflet carefully

Request your repeat prescription before you run out of tablets

Please ensure that you contact your GP surgery before you finish the last blister strip provided in your Cimizt® box (i.e. prior to the pill-free interval). This is important as you may need to allow time to schedule a check-up with a healthcare professional before you are given a repeat prescription.
